'23-'64 Imprint Copyright Determinator Final Report

Narrative

Determining the copyright status of books has become a pressing issue as libraries and business concerns develop plans to digitize older literatures and make public domain works widely available. Organizations need to determine, efficiently and with some certainty, the copyright status of each work in a large collection. Copyright status of books published in the US between 1923 and 1963 is of particular concern, as a renewal registration was required during that period. However, the Copyright Office's published listings of those renewals are spread across print and electronic sources, and are difficult to search. In this project, Stanford University Libraries & Academic Information Resources (SULAIR) sought to streamline access to these renewal records as a preliminary step in the development of an automated system for the determination of copyright status of works.

The Copyright Renewals Database (CRD), assembled by SULAIR under this grant, brings the print and electronic renewal records of the US Copyright Office for US books published between 1923 and 1963 together into a single, consolidated, searchable database. The database is now publicly available at http://collections.stanford.edu/copyrightrenewals. Our testing indicates that the database is more than 99% accurate.

The CRD does, however, have limitations. There is a significant potential for user error in searching. Additionally, the CRD only involves Class A (book) renewals, not other forms of copyrighted material, which may sometimes appear in book form. The CRD does not include assignment of rights, so the CRD can show that a particular work was renewed, but not necessarily the current owner of a work. Finally, the CRD does not account for restored copyrights: those works published simultaneously in the U.S. and foreign jurisdictions, which have had their U.S. copyright restored to them by virtue of the works remaining in copyright in the foreign jurisdiction. Notwithstanding these limitations, the database is already in use as a standalone tool by a number of organizations, and significant positive input has been received.

In addition to development of the CRD, SULAIR expanded on the preliminary work of Lawrence Lessig, and examined the potential for automating the overall analysis of the copyright status of a work or group of works, with the understanding that the CRD data would be an important input into that system. Going forward, we hope to work with partner institutions to expand that analysis into a functional analytical system.

a. Activities, Process and Outputs

The development and testing of the Copyright Renewal Database (CRD) was the primary area of activity for this grant, and the main outputs were the database itself and the record of the test results. Both the database and the test results are publicly available on SULAIR's website: http://collections.stanford.edu/copyrightrenewals. Details of the development process and results of the testing are below.

In addition to development of the CRD, we examined the potential for automating the overall process of analysis of the copyright status of a work or group of works, with the understanding that the CRD data would be an important input into that system. We developed a flowchart for copyright analysis based on the work of Lawrence Lessig, an early advisor on the project, and others including Peter Hirtle¹. We are now actively engaged in conversations to develop our flowchart into a fully functional tool for copyright analysis.

Database Development

For books originally registered with the Copyright Office between 1923 and 1963, renewal was required after 28 years. Therefore, renewal should have taken place between 1950 and 1992. In our project, we looked only at renewal records for 1950 forward, as that date corresponds with the beginning of Project Gutenberg's transcription work, discussed below. The Copyright Office moved to electronic records in 1978, which meant that for our database, we had to combine the 1978-1990 electronic records with the 1950-1977 print records. The fields already existing in the electronic records were used to determine the fields that would be required in the database.

From 1950 to 1977, the Copyright Office published listings of copyright renewals in a biennial publication known as the Catalog of Copyright Entries (CCE). In order to create fielded database records from these print records, SULAIR leveraged work done by Project Gutenberg in transcribing the CCE records into ASCII files. Those files are available online at the Project Gutenberg website. Initially, we had hoped to leverage the work of Prof. Michael Lesk of Rutgers University, who had made an early attempt at the creation of a renewals database, but for technical reasons we determined it was more efficient to start from scratch and reparse the files. The most significant challenge for this portion of the project was identifying author name data and extracting it from the text field. We developed a rubric for extracting this data, as well as identifying other standard record fields, and worked with an external text processing company, Innodata Isogen, to reparse the records.

Beginning in 1978, the Copyright Office ceased publication of the CCE and published all of their registration records, including renewal records, in an online database. Those records are available through both web and telnet interfaces, and the underlying data set is also available for purchase. We worked with the records as extracted from the Copyright Office's online database by a member of the Project Gutenberg team. The database was initially launched using a set of these records that had been tagged and formatted by Michael Lesk for his project. Our initial round of testing uncovered a small number of errors in those records, and so we again went back to the original files, developed a rubric, and again worked with Innodata Isogen to reparse the data.

Database Testing - Methodology

Two rounds of revision and testing were performed on the database. In each round, we pulled a minimum of 500 book titles that had been published in the US between 1923 and 1963 from the Stanford library catalog. It was decided to use materials that were held in-house at Stanford so that we could look at the original works if necessary. A

student searcher was hired to check the copyright renewal status of these works manually in the CCE. The student was given instruction in the use of the tool, and was asked to follow a standard searching procedure. In the first round of testing, a subset of 102 records was also sent to the Copyright Office to be researched by their in-house staff in their main catalog. Each of these items was then separately searched by project staff in the Copyright Renewals Database.

Database Testing - Results

A set of 545 items was reviewed in the first round of testing, and initial results showed 45 discrepancies in search results between the manual search and the CRD search. These items are shown in Appendix A. In addition, we had 8 discrepancies among the 102 items that were sent to the Copyright Office to be searched. While this large number of discrepancies was initially quite shocking, we quickly discovered that the vast majority of these were due to issues with our search methodology or the design of the database, rather than an actual error in the data.

Of particular note is the fact that many works that are classified as books in the Stanford catalog are actually copyrighted as either dramas (Class D) or serials (Class B). As the database includes only Class A registrations, these renewals are not found in the database. As the database was structured to contain only Class A registrations, these 5 discrepancies were determined not to represent errors in the CRD. An additional 6 of the 45 manual search discrepancies in the first round were found to be related to confusion among searchers about editions of the works being searched. 29 of the discrepancies were due to search methodology issues - either in use of the database (i.e. appropriate searching of colons and apostrophes), notation errors (i.e. different methods of recording unusual search results), or simple error (i.e. a record that exists in the database was not located in the first search, but found easily in a second search). Search techniques were revised in preparation for a second round of testing based on this input.

The remaining 5 manual search discrepancies were of the most concern, as they related to issues with the data in the CRD (see Appendix A, lines 103, 122, 212, 325, and 478). The first of those (line 103) was found to be a carry-over problem from the original CCE (i.e. the title printed in the CCE was incorrect), and after some debate we determined not to consider that item an error in the CRD, as we looked to the CCE data to serve as a baseline. Two errors (lines 122 and 212) were tracked to a problem with Stanford's import process after parsing. The process was revised and the data restored. The remaining two errors (lines 325 and 478) were traced to problems with the post-1978 records, which had been extracted from the Copyright Office online database and parsed by Michael Lesk.

Based on an error rate of 4 items out of 545 (0.7%), we judged the initial accuracy rate of our database to be high enough to post on the internet, in order to receive feedback. At the same time, we began re-parsing the post-1978 records to correct the identified errors, and we also began revising our search methodologies.

Of the 8 discrepancies between the Copyright Office (CO) and CRD searches all but two paralleled the discrepancies between the manual and CRD searches. In the first of the two non-parallel cases (Appendix A, line 258), the CRD search noted renewals of alternate editions of interest that the CO did not find. In the other, the results returned by

the CO are for a different work than the one referenced in the Stanford catalog. In both cases, we determined CRD to be providing a more accurate response.

In the feedback we received following rollout of the database, we did learn of an additional error of transcription between the CCE and the Gutenberg text files. That error has now been corrected in the database, and we will continue to correct those errors as we learn about them.

A second round of testing was completed following the re-parsing of the post-1978 records. A set of 500 items was researched in this round. The comparison Copyright Office search was not duplicated. 26 discrepancies were found, as shown in Appendix B. 13 discrepancies were once again determined to be related to search methodology issues. 10 were due to confusion about the edition or version of the work being searched, and one was due to a record class conflict.

The remaining two discrepancies do represent failures of the CRD database. Based on this error rate of 2 out of 500 records (0.6%) we have determined to continue to make the database available. Our conclusion is that while the overall accuracy level of the database itself is quite high (>99%), the nature of the records leaves significant room for user error in the use of the database. We also recognize that there is room for improvement in the accuracy level of the database, and will continue to refine the resource as we work to integrate this data into a copyright analysis system.

The table below summarizes the discrepancy types uncovered in each round of testing.

As earlier studies have estimated the percentage of books renewed during this period as low as 7%², it is noteworthy to see a renewal rate of approximately 30% for a research collection.

Project Review

Our proposal also indicated that we would seek legal input on the validity of the Copyright Renewals Database as a tool. Throughout the project, we consulted with our internal General Counsel, most particularly Lauren Schoenthaler.

b. Progress & Next Steps

The Copyright Renewals Database is complete, available, and validated, and initial reaction from users has been very positive.

Rollout of the database was covered by the Chronicle of Higher Education, and discussion in the blogosphere has been very positive. A comment sent to Stanford by Richard Workman of the University of Texas at Austin demonstrates the sentiment:

I've just become aware of Stanford's Copyright Renewal Database, and I wanted to congratulate you on making such a hugely valuable resource available online. This will prove immensely useful to the public and to those of us who are frequently the recipients of questions about publications from that 40-year gray area.

The database has received significant attention in the blogosphere, and a listing of references to the site is attached as Appendix C. We anticipate receiving continued feedback and input from users, and will update and revise the database according to that input as appropriate. However, based on the input we received to date, we anticipate that those changes will be minimal.

More pressing is the need to develop a system or methodology for determining the copyright status of large groups of works in an automated fashion. The CRD will be a key input to such a system, but significant additional input is required, including such things as author death dates and indication of whether copyright notice was provided in the work. Restored copyrights, as described in section 104(a) of the Copyright Act, are an area of particular concern for Stanford, as some works that may appear to be in the public domain based on a search in CRD may actually be under a restored copyright. We are working to capture these issues in future iterations of the CRD.

c. External Changes Impacting the Project

Abby Smith was originally targeted to serve as Project Manager on this effort, but was unavailable. Therefore, solicitation of a new Project Manager and bringing her up to speed was required. The involvement of partners in efforts to develop a further
