James and Chris,

I am writing regarding the dates that were jointly proposed to the Special Master for expert reports and discovery, which we hope to discuss during Monday's conference. It has come to our attention that Mr. Book has professional and personal commitments, of which we were previously unaware, which will make the current Montana rebuttal disclosure date very difficult. To avoid conflicts and ensure Mr. Book has enough time to complete his work, we would like to build in an extra 2 weeks of time into the proposed schedule. If you are willing, the fairest way to accomplish this seems to be to give each State an additional week in which to complete its expert reports. Other dates would need to be adjusted accordingly, but it would still allow an October trial. Below is our revised proposal for your consideration:
