You will be aware that we are working with Lehman on a Philippines loan of USD35MM (3 month tenor). The lines are already in place, they are just adding obligors to the guarantee.

Either way they need to know soon if they are to look for funding elsewhere but I don't want to string them along much longer and then have to say no. FYI - in response to the downward classification of Lehman, we have started to increase monitoring of Lehman's activity. The CLS line has been reduced to \$960mm (from \$1.5bn) and a manual release process has been reintroduced. We also will collate daily exposure downloads for the \$2.2bn Cash DOL line covering the majority of Lehman's EMEA Cash exposure.

We await instructions from GCC later this afternoon if any further control measures should be introduced.
