Here's the summary level for now - MM is working on pulling position detail.

Clement/Kevin,

Attached is LBI's Inventory Breakout by type of Inventory, this was given to the SEC last week in the formal presentation on LBI. First tab is LMV, Second Tab is SMV.

Please be aware the LMV is in a Regulatory format and includes approx \$4,609mm of Money Mkt Mutual funds in Inventory which would show up in Cash and Securities Segregated on a Top Level (External Reporting) balance sheet. Also, approx \$2,068mm in Inventory on the SEC presentation would show up in Receivable from Broker/Dealer on the Top Level balance sheet, which represents Money Mkt Mutual Funds deposited with different exchanges.

After taking into account the above 2 regulatory topsides, the amounts on the SEC presentation may be slightly off from final Inventory on the top level balance sheet, since the balance sheet may not have been final when we did the SEC presentation.

Will get back to you on the time/effort required to get you position level detail.
