> The Firm received an inquiry from the NYSE requesting information
> concerning Lehman's role in connection with the sale of
> Archstone-Smith (ASN) to Tishman Speyer Properties, L.P. ("Tishman").
> I understand that you are members of the banking team involved in the
> deal.
>
> In connection with this review, the NYSE has requested that Lehman
> produce a detailed, written chronology of the events from the date of

> the firm's first contact with any person affiliated with the deal from
> ASN or Tishman. The specifics of their request are contained in the
> attached NYSE inquiry.
>
> Accordingly, please provide me with the following:
> 1. a detailed written chronology (see sample model chronology for
> guidance)
> 2. a list of all individuals who were aware of the deal prior to it's
> announcement on May 27, 2007. Please be sure to include in this list
> ALL individuals who knew -- such as all Commitment Committee members
> and interns. For each individual, provide: 1) their title, 2) home
> addresses (if available from working group lists, if not, please
> contact me), and 3) the date on which the individual became aware of
> the deal. Additionally, please provide me with the first page of any
> memo that was distributed to committee members in connection with the
> ADS/Blackstone transaction.
>
> The Regulatory Law Group will respond to items 2-5 of the request.
>
> PLEASE NOTE: It is likely that others outside of Lehman have also
> received a chronology request and may contact you to discuss the
> requests or for your assistance. Please refer all such calls/emails
> to me (at 212-526-0878) or Cynthia Ginsberg (at 212-320-7383) and we
> will coordinate with the client. It is important that you not discuss
> this matter with or provide information to anyone else. Such
> communications are not confidential, and could constitute a waiver of
> Lehman's attorney-client privilege.

> where necessary to obtain the above-requested information. If you
