As discussed and agreed by senior management, LBI is requesting a paydown from LBHI of \$1.1 bln USD, value date Today, August 28, 2008, to provide a capital infusion into various subs in which LBI will have a negative investment. The funds which are received into LBI will be subsequently paid down to the entities as follows: \$900mm LCPI (Co 45) and \$200mm LB1 Group (Co 299) value date Today, August 28, 2008. However, since none of these entities have a bank account, LBHI will receive these funds on their behalf (offset vs. I/C). Please see below for journal entry flow.
